This Addendum makes the following revisions to this solicitation. Added text is shown in underline and deleted text is shown as ~~strikethrough~~.

1. The Cover page is revised as follows:

2. Page 3, paragraph 2 is revised as follows:

2. The Pasco County Mosquito Control District (PCMCD) will make a good faith effort to inform prospective Bidders of addenda to the original BID SPECIFICATIONS. IT IS THE BIDDER'S RESPONSIBILITY TO CHECK WITH PCMCD FOR ANY ADDENDA OR CLARIFICATIONS TO THE ORIGINAL BID SPECIFICATIONS PRIOR TO SUBMITTING A BID ~~and before August 7, 2024~~. It is recommended that prior to submission of any bid, that the Executive Director of the PCMCD be contacted at (727) 376-4568 to verify if any addenda have been issued. The receipt of all addenda must be acknowledged on the BID FORM.

3. Page 3 paragraph 4 is revised as follows:

4. Bidder shall complete and submit pages 7 and 8 of this solicitation along with the BID FORM and SPECIFICATIONS for each pesticide for which it is submitting a bid. Bidder must type or legibly print the following statement at the bottom of the form provided on page 8 of this solicitation: "Bidder acknowledges receipt of the following Addenda and agrees that all addenda will be part of the Contract – Addendum No. 1 dated August 16, 2024." The Bidder shall be required to use the BID FORM. Bids received on separate sheets and not attached to the BID FORM and SPECIFICATIONS will be considered informal and will be rejected as such. Any use of brand names, manufacturer's names, trade names, information, and/or catalog

numbers for bid SPECIFICATIONS is to provide descriptions and/or to establish quality levels. Such references are not intended to place restrictions on Bidders, other than as to quality.

4. Page 3, paragraph 9 is revised as follows:

9. The Bidder shall ~~confirm state~~ in the space provided on ~~each the~~ BID FORM a guaranteed maximum delivery time of seven (7) days. This guaranteed delivery time ~~is a minimum qualification for may be an important consideration in the~~ award of the bid. The PCMCD may withdraw the award should the Bidder not deliver the item(s) within the specified maximum delivery period and may award a contract to the next lowest bidder.

5. Page 4, paragraph 17 is deleted and replaced with the following text:

17. Any awarded bid for Altosid P35, Altosid XRG Ultra, FourStar Bti CRG, Naled, Imazamox, Glyphosate, or 2,4-D Amine shall remain firm and valid until **September 30, 2025**. While any awarded bid for Malathion and Permethrin products shall remain firm and valid until September 30, 2027.

6. Page 21, DELIVERY specification for Imazamox is revised as follows:

DELIVERY: Delivery shall be in **1-gallon containers** or 2.5-gallon containers (legally disposable at a sanitary landfill) FOB 2308 Marathon Road, Odessa, Florida.

7. Page 22, PRODUCT – **Imazamox** delivery container is revised as follows:

PRODUCT – **Imazamox**; Estimated 100 gallons (~~1-gallon containers~~ specify whether 1-gallon containers or 2.5-gallon containers)
