- 2. Question 1: Why did the Mosquito Control District decide not to build at this site?

Due to concerns of some Pasco County Legislative Delegation members related to the need and cost of the new campus, the District Board of Commissioners voted to surplus the property during its December 10, 2024 meeting.

3. Question 2: Does the District have a wetland delineation survey for the parcel?

In accordance with the ITB, the District included the Southwest Florida Water Management District Formal Wetland Determination and Delineation in the due diligence documents that a Bidder could request by sending a request to Executive Director Adriane Rogers at ARogers@pascomosquito.org.

The ITB provides for a tour of the Property on January 22, 2025 at 1 PM. Individual tours by Bidders are not allowed except for the sole purpose of completing a formal wetland delineation. Access to the property will be by appointment only for the formal wetland determination. Please see Section 2.V. requirements.

8. Question 7: Are you able to let us know how many people have requested documents and will you be sending out RFI responses?

As of today, there have been three requests for the ITB documents. The deadline to submit a bid is February 12, 2025 and the District anticipates additional requests. Questions may be submitted until January 29, 2025 and the District anticipates providing additional addendum(s) soon thereafter.
